6.1 Minimum Wage

Explanatory Statement: Minimum wage will be increasing by \$1.00 increments until 2022 when it will reach \$15.00. Our current classified salary schedule for January 2018 is covered. Our classified salary schedule at Steps I-III will need to increase by approximately 7% (\$.75) to be compliant by January 2019. Minimum wage as of January 2019 will be \$12.00, 2020 will be \$13.00 etc.

The governing board shall certify, in writing, within 45 days after the close of the period being reported, whether the school district is able to meet its financial obligations for the remainder of the fiscal year and, based on current forecasts, for the subsequent year. The certification shall be classified as positive, qualified, or negative and filed with the county superintendent of schools.
