7.1 Presentation by Jenna Zellmer

Mrs. Zellmer explained the new application, "Recap," that she has been using to teach math to her fifth and sixth grade class. Mrs. Frymire asked if Mrs. Zellmer needed to create the questions, and Mrs. Zellmer responded that she does. Dr. Skulina reported that it was interesting watching the way that kids learned by using this application. Mrs. Noon asked a question regarding accessing school work from home. Mr. McKibban would like to do a survey to see what percentage of Knights Ferry students actually have internet access at home. *Public Comment:* Mrs. McCarthy recommended a survey to find out about not just computers, but reliable internet connectivity. Mrs. Ryan added that having the homework help online is a huge help for her daughter who is in Mrs. Zellmer's class.

7.2 Facilities Update

Dr. Skulina reported that the District did the first test of the new fire alarm today. It still needs some refinement and 1st Security and Sound will come back to finish on April 20th. She added that when she first became the Superintendent/Principal at Knights Ferry, the fire alarm did not alert first responders but was simply just a noise. The District also had the fire sprinkler system inspected, the Fire Marshall came and did an inspection, and a kind parent volunteer put up new blinds on the cafeteria windows. Dr. Skulina and the teachers have been working with a designer regarding modernizing the 7/8 classroom. The Board reviewed the designer's plans and discussed each idea. Dr. Skulina reported that the District may potentially have access to "Financial Hardship" money to possibly pursue building goals. Mrs. Noon explained that the most important project to her was redoing the parking lot. She would also like to assign someone to be in the parking lot before and after school for kid's safety. Dr. Skulina explained that the mornings go smoothly, but after school is much more hectic.

Community: Dr. Skulina presented at the MAC meeting to solicit input regarding what changes the community would like to see happen with the school. The Board would like to send out hard copies of the newsletter every month.

PTC: Mrs. McCarthy reported that PTC decided to approve 50% of the Chrome books and a Smart board. They also decided not to give Mrs. Brockman a gift for doing the Christmas Program and for doing music all year. They are hoping that the school would pay her a stipend instead. They are also no longer funding Accelerated Reader because they are paying for Dreambox.

Teachers: Mrs. McCarthy reported that they are trying to get ready for Open House and they have been doing Science Projects for the Science Fair. There is also a student peeing on the floor in the bathroom every day. The Board discussed ways to address the issue.

Administration: Nothing to Report

Superintendent/Principal: Dr. Skulina is applying for a \$50,000 grant to create a multi-tiered system of support with Valley Home. This would include additional Aide time and Mentors. She applied for a \$3,000 grant to reward kindness throughout the year. Currently the District is implementing the Broadband Infrastructure Internet Grant to get 100mb of data and will get 1GB of data for \$800, per month – a reduction in costs. The District will be putting smoke detectors in in May and will begin trials for science and social studies curriculum. Board of Trustees: Mr. McKibban brought up an idea about helping the community by allowing them to use the school's internet. The Trustee's dinner will be at the same time as Public School Night so none of the Trustees are going to go. Mrs. McCarthy reminded the Board that La Cocina Michoacana is donating 20% of their proceeds that they make from 10am-9pm on April 18th as a fundraiser for the Washington DC trip. Good 'N' Plenty: Peddler's fair is coming up and the Rodeo Parade is this Saturday.
