## **School Facility Conditions and Planned Improvements**

Knights Ferry School is located on 7.717 acres. The school consists of two main buildings and four portables. One of the main buildings was rebuilt in 1974 and has a classroom, multipurpose room, cafeteria, staff room, small work room, two student restrooms, one staff restroom, and storage areas. The other main building was constructed in 1988 and has three classrooms, the office, two student restrooms, and one staff restroom. The portables were brought in as early as 1983 and as recent as 2005. All he portables house classrooms due to student growth over the years prior to 2020-21.. The school is in very good condition. The buildings and grounds are cleaned and maintained regularly. Our custodial maintenance person works daily from 10:30 am-7:00 pm. The buildings are in good repair and no structural work is required. In July 2022, new tanbark was placed into both playground.

A Facilities Master Plan was completed and presented to the community and the School Board in October.

A complete fire inspection was conducted by the Fire Marshall on November 22nd with no corrections needed!

The school sustained storm damage in January 2023 which has all be repaired.

The main buildings were painted and any wood rot or damage was repaired and painted in 2023.

A door was replaced in the girls bathroom stalls.

Current planned improvements are scheduled for the parking lot: expansion and upgrades and two new buildings for the middle school to be completed sometime in 2025.

The Parent Teacher Club continues to raise large amounts of money which are used to offset funding of sports equipment, classroom and art supplies for the art program. The funds are primarily used to provide enrichment such Outdoor Education, the Extended Learning (overnight) Experience at Sutter's Fort, and a plethora of extra curricular experiences.

Parent volunteers are present in many classes on a regular basis though primarily in grades K-4.

Additionally, parent volunteers have provided enrichment instruction during the after-school What I Need program. Primarily designed for academic intervention, siblings of children participating in academic intervention as well as students finished with intervention. Parents and community volunteers have provided Spanish instruction, Yoga, martial arts, and physical fitness activities.

The Knights Ferry Elementary School District has made a commitment to the implementation of Positive Behavior Intervention and Supports and developed the first steps of this transformation in June 2019. Training with the Stanislaus County Office of Education began in August 2019. New, school-wide procedures were developed and implemented in all classrooms.

The PBIS ROARS (respect, ownership, positive attitude, respect, safety) values are fully integrated into the classrooms and are used when students have disciplinary contact.

No students were suspended or expelled in the 2021-2022 school year. One student was suspended in the 2022-2023 school year.

All staff including the regular substitute teachers were trained in an active shooter protocol in August of 2022.

Active shooter drills are held yearly.
